1.4 Superintendent's Comments

Superintendent Javier Montanez – Good evening, President Stephens, School Board Members and the many members of the Providence Public Schools community, thank you for being here tonight. I appreciate your time and commitment to supporting our students and schools.

I want to encourage all families, students and educators to participate in SurveyWorks, Rhode Island's annual education survey. Your feedback is invaluable, it helps us understand what's working and where we need to improve. The more responses we receive, the better we can address the needs of our community.

We've already seen positive changes thanks to this feedback. At West Broadway Middle school, student perceptions of attendance importance increased by 15 percentage points and family perceptions increased by 21 points. This kind of data helps us make real changes that benefit our students.

SurveyWorks is open until March 21st, so I encourage everyone to take a few minutes to complete it. Your voice matters, and your input helps us build stronger schools.

If your child turns five years old on or before September 1, 2025, they are eligible for kindergarten registration. I encourage families to register before May 7, 2025, to secure their spot.

The process is simple. Families can register online through skyward or visit our Registration Center.

While every child will receive a school placement, spots are assigned based on sibling attendance and proximity to neighborhood schools, so early registration is key.

I'm excited to share that we are hosting the Eat, Play, Learn Summer Opportunities Fair on Saturday, April 5, 2025 from 10:00 AM to 12:00 PM.

This is a fantastic opportunity for families to explore free and low-cost summer programs that keep kids engaged, learning and active during the break.

Whether your child loves sports, reading or hands-on activities, there will be plenty of options to explore. I encourage all families to attend and learn more about what's available.

We've made incredible progress in reducing chronic absenteeism, bringing it down from 48.4% last year to 36.2% this year, that's a 12 percentage point drop. This is a huge step in the right direction and we're now below prepandemic levels.

Attendance is one of the biggest factors in a child's academic success and we remain committed to supporting families with resources and awareness campaigns to ensure students are in school and learning every day.

Through our FACE Office, we continue to offer Parent University Workshops to help families navigate everything from cyber safety to the school choice processes to understanding a student's IEP.

The Rhode Island Attorney General Peter F. Neronha and RIDE Commissioner Angelica Infante-Green issued a press release and shared joint guidance with school officials on safeguarding the rights of Rhode Island students regardless of their identity, gender, and sexuality. This guidance also instructs schools that diversity, equity, inclusion and accessibility programs in Rhode Island schools should no change until the legal effect of recent executive actions is settled. Providence Public Schools in turn put out guidance to all families.

In sports, Congratulations to our 2025 Middle School Playoff Tournament Champions! On the court, DelSesto Middle School took home the Girls Basketball Championship, while Nathan Bishop Middle School secured the Boys Basketball Championship! A huge shout out to all the student athletes, coaches and supporters who made this season success.

Congratulations to the Classical High School Girls Swim Team who won the Division 1 State Swim meet at Roger Williams University. This is an amazing accomplishment going from a program that has been in Division 2 for years and was moved up to D1 this year. Thank you.
